Scheme for grant-in-aid to Non-Governmental Organisations for Promotion of Indian Systems of Medicine & Homoeopathy

OBJECTIVES

The main objectives of the scheme are to create and increase awareness among the community about the preventive, promotive and curative aspects of AYUSH systems, its cost effectiveness, availability of herbs used for prevention and treatment of common ailments and the technique for growing such herbs and other medicinal plants. The scheme is intended to create an interest particularly in looking after basic primary health care needs through the ISM&H approach.

ELIGIBILITY

- (i) Mother NGOs identified by Deptt. of Family Welfare for their RCH Programme/NGOs of repute working for CAPART in the field of Community Development.
- (ii) Government Colleges of ISM&H.
- (iii) Other Registered Society of repute, Medical Colleges of ISM&H and Charitable Missionary Hospitals registered as Societies and who have done good work in the field of rural development/community health and any of the systems under ISM&H.

OTHER CONDITIONS OF ELIGIBILITY:

The following are the eligibility terms and conditions:

- (i) It should be a Charitable registered organisation under the Societies Registration Act/Charitable non-profit making organisation/Public Trust registered as such.
- (ii) It should have its own minimum infrastructure i.e. office space, furniture etc.
- (iii) It should have a minimum of three years experience in the field of social service work or a college with 5 years standing.
- (iv) It should engage qualified ISM&H practitioners either on regular basis or on contractual basis required for organising workshops, health melas and community awareness programmes, yoga training & cultivation of medicinal plants.
- (v) It should intimate the details of such qualified staff to this Department within one month of its selection. Grant would be released to the selected agency thereafter.
- (vi) Details of the experts/resource persons along with the qualifications/details of present employment to judge suitability will be necessary for grant-in-aid to be release. **Annexure-A & B** gives the application form and Undertaking.

(vii) It will opt for minimum of 4 activities out of the 5 mentioned above. Participation in health Mela, training workshops and community awareness meetings would be compulsory activities.

FUNDING PATTERN

(1) Participation in melas and organizing health camps

Participation in Melas organised in rural or semi urban areas, on the occasion of regional festivals etc visited by a large section of population will be an eligible activity. Alternately, the agency can organise health camps atleast once in a quarter at different places in the Block. Thus, at least 4 Melas &/or camps shall be organised. The implementing agency will motivate and mobilise community participation in such melas/health camps by launching campaigns through their volunteers and with the involvement of volunteers of Nehru Yuvak Kendras, Gram Panchayat etc.

For participation/organization of such melas/camps, the implementing agency will take the help of medical practitioners of ISM&H working in the area for technical support.

The nearest field units of the Research Councils and National Institutes under the Deptt. of ISM&H and Medical Colleges of ISM&H will also be involved by implementing agencies in such melas/health camps.

The following activities shall be undertaken by the agency:

- (i) Distribution of literature/folders, display through charts and models about the strengths of systems under ISM&H.
- (ii) Exhibition of live medicinal plants.
- (iii) Display of simple apparatus for preparing home remedies like churna, decoction syrup, juice etc and actual preparation of the items on a mini scale suitable for a group of families.
- (iv) Expert health advice, free consultation of Vaidyas/Hakims
- (v) Exhibition of traditional health skills, eg.bone setting, cupping, leech application etc. through traditional healers.
- (vi) Audio-visual shows, skits, nataks, plays
- (vii) Educating people about the utility of cultivation of medicinal plants in their kitchen gardens, back lawns etc.

(2) <u>Training Workshops for ISM & H Practitioners</u>

The Implementing Agencies will identify ISM&H practitioners working in the area and will organise two day workshop for not more than 20 practitioners in a quarter. Thus 4 training workshops would be held, 2 for Ayurveda & Siddha, 1 for Unani and 1 for Homoeopathy practitioners. In the Workshop, these practitioners will be motivated to practice their own system and use their drugs. The participants would also be made aware of the various legislations concerning ISM&H, such as, Drugs & Cosmetics Act, Magic Remedies Act, CCIM, CCH Act. etc. In these

workshops, the participants would also be advised to educate the masses about the commonly available medicinal plants and the role these plants play in the cure of common diseases. Information on new procedures, treatment, drugs and developments should also be provided. These Training Workshops will be organised in coordination with the nearest medical college of ISM&H under the supervision of one of the Faculty Members of the colleges. Such identified medical college of ISM&H would be given financial assistance for technical support by the implementing agency.

3. <u>Community Awareness Meetings</u>

The Implementing agency will organize at least one community awareness meeting in a month in a cluster of 2-3 villages/wards in the area of its operation with the help of Mahila Mandals, Yuvak Sanghs, Schools, Self help groups, Gram Panchayats and Farmers' Cooperatives/Women Self-help Groups of the area. In these meetings, they will educate the people about "Dincharya-Ritucharya" good healthy living practices, knowledge about the seasonal diseases, their prevention/cure through home remedies.

For undertaking these activities, the selected agency would associate the faculty members of the nearest medical college of ISM&H/district Health authorities or institutionally qualified practitioner in the area.

(4) Demonstration of Yoga in Primary School

The implementing agency will organise demonstration of Yoga and teaching to the students of primary classes with the help of qualified Yoga teachers or through known yoga experts. The students will also be taught about healthy life styles. The implementing agency would identify maximum of four schools in a Block and would conduct at least 8 classes in a quarter in each school. Selection of the Yoga instructor and the instructor for giving lessons on the healthy life styles will be engaged either from a recognised Government ISM&H Institution or from any Institute having the recognition of the Central or State Government for teaching Yoga. The instructor will be paid honorarium @ Rs.100/- per class of 1 hour.

(5) Cultivation of Medicinal Plants in Rural/Tribal Areas

The Implementing agency will select a group of 20-30 farmers from different villages in the block and organise a one day training at the block level to educate these farmers about the usefulness of growing medicinal plants and the agrotechniques for growing medicinal plants. They could also be made aware of the agencies to whom they could possibly sell their products, and given training for preserving and packaging of such products. These training programmes could be conducted in association with the nearest ISM & H Colleges/field units of the the Department of ISM & Η Research Councils of or through Agriculture/Horticulture officers at the Block level. The selected agency would conduct at least three trainings in a quarter. Saplings of medicinal plants shall be

given free of cost to the participants by the agency. While selecting the participants for the training, preference will be given to members from youth cooperatives, DWCRA groups, Vana Sanrakshana Samities in forest areas and DRDA and SC/ST beneficiaries.

ELIGIBILITY

Scheme to be implemented as Central Sector Scheme by the Deptt. of ISM & H with inputs from State Govts., Drug Manufacturing Industry, Equipment Manufacturing Industry, Manufacturers of Herbal/Natural Foods.

FUNDING PATTERN

In case of the State Govts. the Central Govt. will meet 100% expenditure on sponsoring persons as well as preparation of publicity material.
